

Software Download User License Agreement

This Download User License Agreement ("DULA" or "Agreement,") is a legally binding AGREEMENT between you ("you" or "licensee") and Inlite Research, Inc. ("INLITE") and pertains to the specific INLITE "Software" product licensed by you among the list set forth in Section 1 (Definitions) below.

By selecting "**I Agree**" or clicking "**Next**", or by installing, copying, or otherwise using the Software, you agree to be bound by and comply with the terms and conditions of this Agreement.

1. DEFINITIONS.

1. The "Software" means and pertains to each of the following INLITE products:
 - i. Software Development Kits (each an "SDKs"); and
 - ii. Application software, including but not limited to the "Barcode Director" and the "BarcodeReaderCLI"; and
 - iii. Web services software, including but not limited to WebAPI Barcode Reader, including any and all distribution packages, components, upgrades, revisions and supplements thereto.
2. A "Target System" means one (1) of the following:
 - i. a single computer owned or operated by you within your physical premises; or
 - ii. a single computer operated by your service provider – including a computer which is used in a public or private cloud network (however, you remain responsible for the service provider's compliance with this Agreement); or
 - iii. a single virtual machine (or a single cloud Instance)
3. "Production Use" and a "Production Instance" and means one (1) or more occurrence of the Software in object code form used concurrently at the same time on the Target System to support a business process or product.

2. GRANT OF LICENSE.

Any rights not clearly and expressly granted to you under this Agreement are reserved to INLITE. Provided you have paid all applicable fees, registered the Software with INLITE, and otherwise complied with the terms and conditions of this Agreement, then INLITE grants to you during the Term (as defined below), the following non-exclusive, non-transferable and nonsublicensable (except upon prior written approval or as otherwise permitted herein), revocable, internal use, end user copyright license as described below.

A. Grant of Run Time License for the Software and Production Operating Mode of Software.

For each single Run Time License you purchase, you may:

1. install and use one (1) single Production Instance on not more than one (1) Target System.
2. copy the Software for archival purposes, provided that any copy must contain all of the original Software program's proprietary notices.
3. copy and execute the Software separately, or incorporate it into your products' installation process, in order to use one Production Instance of the Software and install its components onto the Target Computer.
4. No other use of the Software is authorized and any unlisted use is prohibited.
5. A paid Run Time License entitles you to obtain technical support and Software updates from INLITE for a period of one (1) year or such other standard period offered at the time of purchase of the Run Time License.
6. The Run Time License must be registered as instructed by INLITE, in order to become effective.

B. Grant of Development License for the Software. :

1. You may use the Software on one Target System solely for non-Production Uses to design, develop and test your program and to determine whether to purchase an Run Time License to

the Software.

2. Each restriction and limitation on installation, copying and use set forth in part A of this Section 2 (Grant of License) also applies to the Development License.
3. Operation under Development License is merely a technology demonstration and may not be at the level of performance or compatibility of INLITE production-level products.
4. Operation under Development License is provided strictly on an "AS-IS" basis with no representations or warranties or support of any kind or nature.

3. RESTRICTIONS.

As a condition of the license rights granted above, you agree that you will not directly or indirectly:

1. install the Software on systems other than the Target Computer, or use the Software in more than one Production Instance (Clone) for each Run Time License purchased; and you understand that INLITE may invalidate license on such Clones at any time; or
2. modify, display, rent, lend, lease, loan, transfer (except as may otherwise be permitted herein), disclose, distribute, or merge the Software; or
3. use the Software in any web service or other online service of any kind or nature (whether such service or provision is provided on a paid or unpaid basis), except to add significant value for internal users or a limited set of registered customers who are not members of the general public (except with the written approval of INLITE) who pay more than insignificant amount for such service; or
4. cause or permit the disassembly, reverse engineering, decompilation, extraction or other decoding of the Software or any portion thereof, or otherwise attempt to obtain through any means, to derive or modify the source code, structure or architecture of the SDKs, NuGet Packages, Software application or the Software code or algorithms therein; or
5. use or combine the SDKs or NuGet Packages with any application that does not provide substantial additional value, including but not limited to use or combination or integration with a **Thin Client** or **Thin Wrapper** application; or
6. transfer the Software to any third party except with the prior written consent of INLITE, except that an SDKs or NuGet Packages may be used to develop a separate product by combining and integrating the same with an application providing substantial additional value ("Customer Product") for license to a third party of the Customer Product with the Software incorporated therein (i.e., and such Software is not usable or provided separate from the Customer Product) if and only if terms and conditions NO LESS PROTECTIVE OF INLITE as the terms hereof are executed by the party licensing the Customer Product, provided that a paid Run Time License is provided by or for the end user.

4. TERM AND TERMINATION.

This License is in effect until terminated (the "Term"), except for grant based on limited term licenses. The License will terminate automatically upon any breach of the terms and conditions hereof, and INLITE may also terminate this License immediately for failure to comply with any of the terms and conditions hereof. You agree that upon termination for any reason, all copies of the Software (whether directly in your possession or with a third party) shall be erased and expunged from every device and form of media and shall no longer be used. Sections 3 through 14 will survive and remain in effect even if the Agreement is terminated, cancelled or rescinded.

5. OWNERSHIP, COPYRIGHT and TITLE.

The Software is owned by INLITE or its suppliers and is protected by copyright, trade secret, patent and other intellectual property laws and international treaty provisions. INLITE retains sole title to and ownership of the Software. All copies and portions of the Software, in any form, belong to INLITE, which retains all rights not expressly granted. Nothing in this DULA constitutes a waiver of INLITE's rights under the laws of the United States or any other country or jurisdiction.

6. NO WARRANTY.

YOUR USE OF THE SOFTWARE IS ENTIRELY AT YOUR OWN RISK. EXCEPT FOR THE LIMITED SUPPORT PROVIDED TO PURCHASERS OF RUN TIME LICENSES AS DESCRIBED IN SECTION 2 A 6 HEREIN ABOVE, THE SOFTWARE IS PROVIDED "AS IS." TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, INLITE DISCLAIMS ALL WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY WARRANTY THAT THE SOFTWARE IS FIT FOR A PARTICULAR PURPOSE, TITLE, MERCHANTABILITY, DATA LOSS, NON-INTERFERENCE WITH OR NON-INFRINGEMENT OF ANY INTELLECTUAL PROPERTY RIGHTS. INLITE DOES NOT WARRANT THAT THE SOFTWARE IS SECURE, FREE FROM BUGS, VIRUSES, INTERRUPTION, ERRORS, THEFT OR DESTRUCTION. NO ORAL OR WRITTEN INFORMATION OR ADVICE GIVEN BY INLITE, ITS EMPLOYEES, DISTRIBUTORS, DEALERS OR AGENTS SHALL CREATE ANY NEW WARRANTIES.

SOME STATES DO NOT ALLOW THE EXCLUSION OF IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION MAY NOT APPLY TO YOU. IN THAT EVENT, ANY IMPLIED WARRANTIES ARE LIMITED IN DURATION TO THIRTY (30) DAYS FROM THE DATE OF DELIVERY OF THE SOFTWARE. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS. YOU MAY HAVE OTHER RIGHTS, WHICH VARY FROM STATE TO STATE.

7. LIMITATIONS OF REMEDIES AND DAMAGES.

IN NO EVENT WILL INLITE OR ITS SUPPLIERS BE LIABLE TO YOU FOR ANY DAMAGES, CLAIMS OR COSTS WHATSOEVER ARISING FROM THIS LICENSE AGREEMENT AND/OR YOUR USE OF THE SOFTWARE OR ANY COMPONENT THEREOF, INCLUDING WITHOUT LIMITATION ANY CONSEQUENTIAL, INDIRECT, INCIDENTAL DAMAGES, OR ANY LOST PROFITS OR LOST SAVINGS, EVEN IF AN INLITE REPRESENTATIVE HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH LOSS, DAMAGES, CLAIMS OR COSTS OR FOR ANY CLAIM BY ANY THIRD PARTY. THE FOREGOING LIMITATIONS AND EXCLUSIONS APPLY TO THE EXTENT PERMITTED BY APPLICABLE LAW IN YOUR JURISDICTION. INLITE'S AGGREGATE LIABILITY AND THAT OF ITS SUPPLIERS UNDER OR IN CONNECTION WITH THIS LICENSE AGREEMENT SHALL BE LIMITED TO FIFTY U.S. DOLLARS (\$50.00). THESE LIMITATIONS ARE CUMULATIVE FOR ALL CLAIMS HOWSOEVER ARISING UNDER ALL AGREEMENTS AND ORDERING DOCUMENTS, AND SHALL APPLY EVEN IF THE REMEDIES PROVIDED IN THIS AGREEMENT SHALL FAIL OF THEIR ESSENTIAL PURPOSE.

8. INDEMNIFICATION.

You agree to defend, indemnify, and hold INLITE and its suppliers harmless from and against any claims or lawsuits, including attorneys' reasonable fees, that arise or result from the use or distribution of your software products, provided that INLITE gives you prompt written notice of any such claim, tenders to you the defense or settlement of such a claim at your expense, and cooperates with you, at your expense, in defending or settling such claim.

9. NOTICE TO U.S. GOVERNMENT USERS.

All INLITE products and services are commercial in nature. The Software is a "Commercial Item," as defined at 48 C.F.R. §2.101, consisting of "Commercial Computer Software" and "Commercial Computer Software Documentation," as such terms are used in 48 C.F.R. §12.212 or 48 C.F.R. §227.7202, as applicable. Consistent with 48 C.F.R. §12.212 or 48 C.F.R. §§227.7202-1 through 227.7202-4, as applicable, the Commercial Computer Software and Commercial Computer Software Documentation are licensed to U.S. Government end users (1) only as Commercial Items, and (2) with only those rights as are granted to other users pursuant to terms and conditions of this Agreement. All unpublished rights are reserved.

10. EXPORT RESTRICTIONS.

You acknowledge that the Software, and the underlying algorithms and components

embedded therein may include U.S. technical data subject to restrictions under export control laws and regulations administered by the United States government. You agree that you will comply with these laws and regulations, and will not export or re-export the Software, or any part of the Software, in violation of these laws and regulations, directly or indirectly.

11. NO WAIVER.

The failure or delay by any party to enforce any provision of this license shall not be construed to be a waiver of such provision, and the waiver by any party of any breach or violation of this license shall not be deemed to constitute a waiver of any future succeeding breach or violation.

12. GOVERNING LAW; EXCLUSIVE JURISDICTION.

This DULA is governed by the laws of the State of California, U.S.A., without regard to its conflict of laws provisions, and you agree except with respect to for matters of injunctive relief, to the exclusive jurisdiction of the State and Federal courts in Santa Clara County, California for enforcement of this Agreement and with respect to all disputes arising in connection with this agreement. Should any court of competent jurisdiction declare any term of this DULA void or unenforceable, such declaration shall have no effect on the remaining terms hereof.

13. GENERAL.

This Agreement is the entire agreement between you and INLITE and replaces all prior understandings, communications and agreements, oral or written, regarding its subject matter and supersedes and applies notwithstanding and in lieu of any purchase order terms and conditions provided to INLITE which will have no force or effect. Notwithstanding the foregoing, if you have an OEM or other existing agreement with INLITE which provides for additional or different terms and conditions, the terms and conditions hereof do not replace that agreement. If any court of law, having the jurisdiction, rules that any part of this Agreement is invalid, that section will be removed without affecting the remainder of the Agreement. The remaining terms will be valid and enforceable. The United Nations Convention on Contracts for the International Sale of Goods does not apply to this Agreement. You cannot assign or transfer ownership of this Agreement to anyone without written approval of INLITE. However, INLITE may assign or transfer it without your consent to (a) an affiliate, (b) a company through a sale of assets by INLITE or (c) a successor by merger. Any assignment in violation of this Section shall be void.
